



Structural steel framing is designed by structural engineers, or architects with a certification. An engineer's stamp must accompany any controlled design and inspection document. Fabricated cold-rolled steel must be primed and fireproofed according to the designing engineer's ASTM fire-rating 'assembly;' typically indicated in hours. Structural steel installation must be performed by a licensed welder or ironworker.


The two most common construction accidents are either falls, or being struck by an object. Steel rigging and erection are particularly prone to these exposures.

OSHA has a standard protocol and set of guidelines for steel rigging and erection, in its 29-CFR, which are as indicated in the Appendix.




