The term Unidentified Flying Object implies an aerial craft impossible to accurately identify as belonging to a human pilot or within the bounds of human technical expertise. Such designs for UFO's throughout history have ranged from disk-shaped, tic-tac-shaped, come-shaped, rocket-shaped, cigar-shaped, spherical-shaped, cube-shaped etc. and continue to grow as more reports are filed and recorded every year.

The primary claim surrounding UFO's believes that many of the craft are piloted by extraterrestrial or interdimensional intelligences, originating from a place other than the earth in both space or time. Although direct evidence for such a claim is difficult to gather, the tremendous flight capabilities of such craft, seemingly capable of traversing through atmosphere, underwater and in space, imply ease of travel across vast distances of intense vacuum and zero gravity.



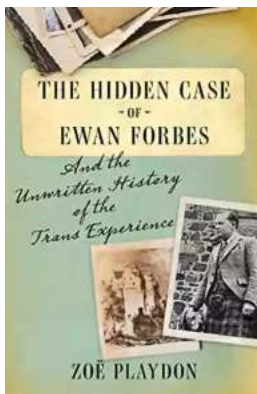
