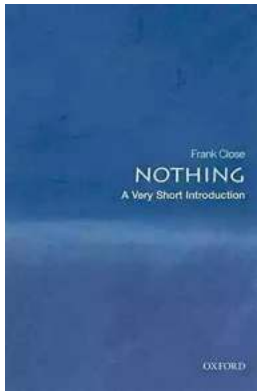

As for (iii) above, MiBot drafts contracts by reflecting the information collected from the users and other sources. MiBot also reviews contracts by comparing the

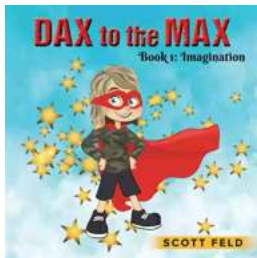
contract drafted by MiBot with the contract obtained by the other party.
